<b>Core Purpose</b>	<ul style="list-style-type: none"> <li>Work with class teachers to raise the learning and attainment of pupils</li> <li>Give support to pupils, individually or in groups, so they can access the curriculum, take part in learning, and experience a sense of achievement</li> <li>Promote pupils’ independence, self-esteem and social inclusion</li> <li>Have high expectations of all students with a commitment to helping them fulfil their potential</li> <li>Promote the safety and wellbeing of pupils, and help to safeguard pupils’ wellbeing by following the requirements of Keeping Children Safe in Education (KCSIE) and our school’s child protection policy</li> </ul>
<b>Main Responsibilities – Teaching &amp; Learning, Support</b>	<ul style="list-style-type: none"> <li>Demonstrate an informed and efficient approach to teaching and learning by adopting relevant strategies to support the work of the teacher and increase achievement of all pupils including, where appropriate, those with special educational needs and disabilities (SEND)</li> <li>Know how to support learners in accessing the curriculum in accordance with the special educational needs (SEN) code of practice and disabilities legislation</li> <li>Support students who have physical disabilities and/or medical needs</li> <li>Understand the objectives, content and intended outcomes for the learning activities in which they are involved</li> <li>Promote, support and facilitate inclusion by encouraging participation of all pupils in learning and extracurricular activities</li> <li>Support the teaching of a broad and balanced curriculum aimed at pupils achieving their full potential in all areas of learning</li> <li>Recognise and respond appropriately to situations that challenge equality of opportunity</li> <li>Use effective behaviour management strategies consistently in line with the school’s policy and procedures</li> <li>Observe pupil performance and pass observations on to the class teacher</li> <li>Use and promote ICT skills and assistive technology to advance pupils’ learning</li> <li>Undertake any other relevant duties given by the class teacher</li> <li>Support pupils in exams who have Exam Access Arrangements</li> </ul>

<b>Planning</b>	<ul style="list-style-type: none"> <li>• Use area(s) of expertise to contribute to the planning and preparation of learning activities, and to plan their role in learning activities</li> <li>• Contribute to the selection and preparation of resources suitable for children and young people's interests and abilities</li> <li>• Use allocated time to devise clearly structured activities that interest and motivate learners and advance their learning (1-1 or small group interventions)</li> <li>• Work closely with the teachers to ensure students' needs are met and understood</li> <li>• Contribute to the Faculty's Area School Improvement Plan and its implementation</li> <li>• Assist the SENCO in identifying resource needs</li> </ul>
<b>Working with staff, parent/carers and relevant professionals</b>	<ul style="list-style-type: none"> <li>• Communicate effectively with other staff members and pupils, and with parents and carers</li> <li>• Communicate your knowledge and understanding of pupils to other school staff and education, health and social care professionals, so that informed decision making can take place on intervention and provision</li> <li>• Contribute to meetings with parents and carers by providing feedback on pupil progress and barriers to learning</li> <li>• Collaborate and work with colleagues and other relevant professionals within and beyond the school</li> <li>• Support students on visits and out of school activities as required</li> <li>• Be a Key Worker for identified pupils</li> <li>• Create/update Pupil Passports along with the pupil and parent/carer</li> </ul>
